Proposals will be evaluated using a Quality and Cost-Based Selection procedure, in which the Technical Proposal can be awarded a maximum of 70% of the evaluation score, and price, a maximum of 30% of the evaluation score as described in Section 10.0 of the TORs. 6. Any request for clarification must be sent by 29 May 2026, with the heading, “Request for Clarification” in writing by electronic mail to the email addresses listed above. 7. Interested Consulting Firms / Consortium should submit their Proposals in PDF format. 8.
